Doing the Leg Work

Brothers and sisters, there is nothing more I like than to represent you and your needs. However, sometimes it is an uphill battle when we are not fully prepared to go to war. I have heard several members' concerns about specific issues, and we (your Executive Board) always want to address those issues. However, we cannot do it alone and we cannot do it without you.

I know I sound like a broken record when I say, "File the grievance", but doing your part and doing the first part of the grievance procedure is fundamental in any CBA or MOU. Yes, I know: It is a long and sometimes drawn-out process, but doing so lays the foundation we need to get something addressed. If it is in the CBA/MOU already, file that grievance. This is the tool we need to fix things.

Think about it this way: If you take your car to a mechanic because of an electrical issue, that mechanic wouldn't be able to fix it without using a voltmeter, test lights, or even possibly a computer, if needed. Those are the tools that help to diagnose the problem your car may have.

In the business of representation, grievance forms are the tools we need so we can address what's broken. Although the grievance might get denied, we have started a paper trail. With enough paper behind it, we can possibly make a strong statement to the agencies during negotiations. So even if we don't get it fixed right that instant, it may give us some support when we go to the table during negotiations. Who knows? We may even catch management on a good day and get the grievance granted. The point is, your Executive Board will keep on fighting for all of you. But when we don't have the paperwork to back us up, we can only get so far.

I'll use an example out of our RTA unit. Article 16, Section G, Meals and Rest, spells out the process to report loss of time on paddles. Loss of time is one of the biggest issues with our Operator brothers and sisters, because they do not get the proper amount of rest time that is supposed to be built into their paddles. There is no shortage of complaints amongst us, but when it comes to putting it on paper and following this process, we have none. Yes, I've heard this before: "I file it and they don't fix it." Or: "They fix that paddle but screw up something else." I hear you. However, this goes back to the point I made earlier: Paper trails.

During our past negotiations, we called RTA's attention to the fact that due to the way they schedule their runs, our Operators are not getting their scheduled rest time. When asked, where's my proof, we had no paper to show it. Management sat there and said, "This is the first we've heard about this, why haven't they filed the grievance?"

The thing to remember is that this is not a one and done; you must file a grievance every time there is a contract violation. Imagine if we had stacks and stacks of grievances to show that there had been a pattern. Doing the leg work and building the foundation gives us a much better chance at getting the change that you all expect and need.

Brothers and sisters, you have the tools. Grievances are the Union's tools. Let's use those tools provided to us. Doing the leg work now helps lay and build the foundation for a better fight. Thank you in advance for your understanding and cooperation.

Together, Let's Continue to Make a difference!
