# **Los Angeles County Federation** of Labor's Endorsements for the June 7 Primary

It matters who we support Political deliberations and and who we oppose. decisions affect our worksites, homes, families, and futures. There you have it, brothers and sisters: Organized labor's political voice in our area recommends these men and women as the best incumbents (and candidates) to serve working people's needs and goals. I strongly urge you to consider these people, and please be registered to vote on June 7 (or before, if you mail in your ballot). Thank you.

A special note on the Los Angeles Mayoral election for our members and families who live in the city: Although this is officially a non-partisan election, the two best candidates for mayor in the June 7 primary are Democrats Karen Bass and Kevin De Leon.

Congresswoman Bass has been a strong voice and vote for union families and a progressive agenda in social, economic, and political matters. She was equally supportive of our agenda when she served in the California Legislature.

L.A. City Councilman De Leon is a longtime advocate for working people and families. In the California State Legislature (the Assembly and the Senate) and on the City Council, he has been a reliable author of progressive legislation and a solid vote.

It is critical to note that either Bass or De Leon would be far superior to real-estate developer and businessman Rick Caruso, who is

also running for mayor. Caruso, who is pouring millions of his own dollars into his campaign, would reflect the interests and goals of Los Angeles' business community and downtown power brokers, who are almost invariably against the needs and goals of unions and the working people and families they represent. He would represent a serious step back from the progressive, pro-worker advancements of the past few years, and could well pose a threat to union influence and achievements in the city!

#### **Notes from the Front Line**

ATU Local 265 secures benefits for the families of our brothers who were killed in the May 26, 2021, mass shooting. Next month is the one-year anniversary of that dreadful day. I am pleased to report that the Santa Clara Valley Transportation Authority (SCVTA) has recently announced that the families of the nine victims (along with the family of another brother who survived the assault, but later took his own life because of mental anguish) will receive much-deserved—and needed—retirement benefits.

Our sister local union worked closely and productively with SCVTA to come up with a deal that provides benefits to the families who lost both their loved ones and main source of income and security. The Authority's Board of Directors *unanimously* voted to give \$4.9 million overall in retirement benefits to the 10 families. What is most interesting and pertinent about this gesture is this: Seven of the 10 victims weren't old enough (or had not been working at SCVTA long enough) to be eligible for those pension benefits!

I salute the determination and caring shown by ATU Local 265's leadership that secured these timely and significant benefits for the surviving, still-grieving family members left behind after this devastating tragedy.

Following the outrageous, inexplicable subway shooting spree in New York City in mid-April, ATU International President John Costa once again spoke out against violent crime on public transit systems in general, and specifically against attacks on our brothers and sisters who work in those systems.

Charing that elected officials and transit agencies themselves have, for far too long, turned a blind eye to the rising incidents of violence, Costa said, "For years, they have just been sweeping I under the rug and hiding it." He cited numerous examples of violence against coach operators and other publictransit workers, and demanded that governments at all

levels, along with transit agencies, *immediately* take long-overdue and very necessary action to curb this spiral of violence and hatred.

#### Amen to that!

The Biden Administration extends the mask mandate on public transit. Acting prudently and decisively, the federal Transportation Security Administration (TSA) extended the mask mandate for all operators and passengers on public transit systems across the country into at least mid-May. This action, announced by the CDC, was taken in response to the new BA.2 variant of Covid, which has caused a spike in infections. The mandate covers all public bus, rail, and air systems, as well as the inside of train stations and airports. The ATU strongly supports this protective move that helps safeguard the health and safety of our members and their families, and the riding public.

It's *impossible* to argue with this extension and the reasoning behind it!

# Keeping a lookout at MTA

Never Underestimate the Importance of Observing Warranty, Campaign, or Subcontracting Work

From time to time, our members are asked to go and observe either some warranty work or a subcontractor who is providing a service to MTA. Sometimes, members are asked simply to keep an eye on a vendor who is introducing a new product to the industry and would like to try it out on the bus or at one of our facilities.

When requested to observe, oversee, or birddog a vendor, it is important that you do so for a couple of reasons. *One is to safeguard the Authority property, and the other is to safeguard your fellow MTA-unit members.* Sometimes, contractors are just left unattended; this un-attention could have farreaching effects.

For example, things like tools or supplies can simply disappear. Or, some damage may result to the Authority's property—and that could lead to one of our members being wrongly accused of causing it. If no other witness is present during this time, the blame may fall on a fellow member.

#### The ATU-MTA CBA Provision

Here is the relevant provision in our current contract with MTA (Article 11, Section C—General Contracting—Sub-section 6):

"Any and all maintenance and repair work when a warranty is in effect. If the work is done at an Authority facility, an ATU-represented employee will be assigned to work with the employees of the subcontractor; in such case, the ATU-represented will receive his/her regular rate of pay or the W.E.M. rate of pay, whichever is higher.

"If the work is not to be done at an Authority facility, an ATU-represented employee need not be assigned to work with the subcontractor's employee."

#### 2009 Side Letter of Agreement

This further interprets and confirms the right of an ATU Local 1277 member to observe warranty or subcontracting work.

#### **Bus Warranty**

"For warranties on bus, at least one ATU-Represented employee will be assigned to work with the employees of the subcontractor for each warranty component listed in Side Letter 2006-005, excluding the warranty on the complete bus.

"However, if multiple employees of the subcontractor are working on the same component on multiple buses, at least one ATU-represented employee will be assigned. This provision applies to components under warranty repair on a location basis. For components not listed in the Side Letter, W.E.M.s will have the first call on the above warranty work."

#### Rail Warranty

"Rail cars are accepted on a conditional basis prior to commencement pf the warranty period. Beginning 9-27-2012, new rail warranties have a nine (9) month limit after conditional vehicle acceptance before the commencement of the warranty period.

During the period of conditional acceptance, and prior to commencement of the warranty period, LACMTA will assign one ATU-represented employee to work with the employees of the subcontractor.

"After full acceptance (or the nine-month period referenced above, whichever occurs first) of the rail car, and during the warranty period, LACMTA will assign at least one ATU represented employee to work with the employees of the subcontractor for each component under warranty repair at each location."

If a W.E.M. (Warranty Equipment Mechanic on the Bus side) or a R.W.E.S. (Rail Warranty Equipment Specialist on the Rail Side) are unavailable, and MTA management has requested that a Floor Mechanic or Maintenance Specialist do W.E.M./R.W.E.S. work, they <u>must</u> be paid the corresponding wage rate and they <u>must</u> observe the vendor at all times.

This applies to each component that is being worked on. For example, if a vendor works on doors, a W.E.M./R.W.E.S. must be present to monitor that vendor's work. If two vendors are on property working on different components—for example, one working on doors and another working on turbo replacement—then two W.E.M./R.W.E.S. must be monitoring each vendor. This is so not only to protect MTA's property, but to protect a fellow union member from being wrongly accused of damage or neglect of the Authority's property.

So, brothers and sisters, please take these job assignments, if and when they are offered or assigned. What may at first seem like a waste of your time is most certainly *not* one; your time and attention could very save lives and jobs!
